#### **Meeting Minutes**

## **Director's Report**

Adele Infante reported that Library staff collected 30 pounds of plastic for Carissa Wood's recycled dog park bench project.

John Kenny shared information on his recent initiatives with the Grafton Correctional Institution including a new book discussion group, a Hispanic Heritage Awareness display, and book donations for kids. Discussion followed.

Adele intends to close the Library on October 28 due to a planned power outage in the Village.

Adele reviewed changes to the Unattended Children and Vulnerable Adults policy. The Board recommended separating the procedures from the policy, making additional revisions, and bringing the updated documents to the November meeting for further review. Discussion followed.

#### **Planning Committee**

Following the visit of Rick McCarthy from GC Studio Design last month, the Board intends to concentrate on identifying and creating focus groups to determine the community's preferences in a new library building and location.

Clare Gallaher moved, and Evelyn Hemmingsen seconded to accept Resolution # 23-9-3, approving the decision to move forward with Studio GC to set up focus groups and getting cost estimates up to \$20,000. All voted aye. Motion carried.

#### **Social Committee**

Corey Heredos provided information on holding a bowling event for the Board and staff to attend, including cost estimates. Discussion followed.

The Board agreed to plan special breakfast or lunch events throughout the year for staff during normal Library hours to show their appreciation, rather than planning one annual event each year for this purpose.

#### **Midview School State of the Schools**

John Kenny attended the State of the Schools event at Midview High School and provided meeting details. At the meeting, School Superintendent Bruce Willingham reviewed the district's culture, academic achievements, programs and activities, and statistics. Treasurer Mike Resar discussed financials and changes to open enrollment.
